Information We Disclose

How Information Is Safeguarded

We have procedures in place that we believe are reasonably designed to protect the security and confidentiality of your information. These include confidentiality agreements with companies we hire to help provide services to you, password-protected user access to our computer files and strict confidentiality policies that apply to all Main Street Investments personnel.

Opt-Out Provision

Pursuant to the privacy policy, if at any time a client does not wish to have any of his/her NPI (non-public information) disclosed to a third party, the client can telephone our Chief Compliance Officer at 913-802-4015 to notify him or her of such decision. The CCO shall keep a list of any Client who opts out of disclosure and will consult such list prior to disseminating any client NPI to a third party.

How Information Is Stored

Regulations require us to archive our interactions with clients when delivering financial or investment advice. This includes emails, text messages and other messages sent to both Main Street employees' personal and business accounts.
